## » SENIORS HOUSING PAC UPDATE

The 2020 Seniors Housing PAC Campaign is set to launch this month, and ASHA members will soon receive information about to support ASHA's legislative efforts on Capitol Hill.

Last year's Campaign raised \$409,624 from 432 contributors from a total of 85 member companies. The top Campaign of 2019 (by total funds contributed) was run by Senior Lifestyle (\$30,655), followed by Senior Star (\$25,193), Senior Resource Group (\$20,010), Senior Living Investment Brokerage (\$18,150), Capital One Healthcare Real Estate (\$14,100), Watermark Retirement Communities (\$13,250), Hanson Bridgett (\$12,000), Ventas (\$11,151), and Hawthorn Senior Living (\$11,000). The Seniors Housing PAC disbursed \$381,500 to 41 U.S. Senators and 79 members of the U.S. House of Representatives on a bi-partisan basis.

# » WHERE YOU LIVE MATTERS UPDATE

The new Where You Live Matters (<a href="www.WhereYouLiveMatters.org">www.WhereYouLiveMatters.org</a>) website was relaunched last fall to optimize user experience and provide a wide array of resources for marketing and sale professionals to share with prospective consumers. Through the end of December 2019, 261,574 visited the Where You Live Matters website, surpassing the total number of visitors in 2018 by more than 43,000.

ASHA members are strongly encouraged to submit their owned or operated communities to the Community Search Locator Tool on the website. The Community Search Locator displays communities up to a 100-mile radius in both the U.S. and Canada by community name, levels of care, address, city, state, ZIP code and country, and links to communities'

websites are included. To date close to 4,000 communities are included in the search feature, and analytics suggest consumers are actively searching for communities, with time on the locator averaging 8:58 per visit.

#### PROFILE OF AL DIRECT CARE WORKFORCE

The January issue of the Journal of Applied Gerontology (2020, Vol. 39) includes an article by Christopher Kelly and Jerome Deichert of the University of Nebraska and Jennifer Craft Morgan and Candace Kemp of Georgia State University, that analyzed data from the 2014 American Community Survey to identify the demographic and employment characteristics of assisted living direct care workers. The study provides demographic characteristics for direct care workers in assisted living, nursing homes, hospitals, outpatient care centers, home health care, individual and family services and private households. Among other things, the researchers found that AL direct care workers were more likely than other direct care workers to be younger, male, white, and English-speaking, U.S.-born, never-married and to have attended college.
