The meeting will feature a panel discussion of industry leaders and other pertinent business. ASHA and NIC Leadership will then hold a joint networking reception.

A full agenda will be provided in the coming weeks.

IMPORTANT PROOF OF COVID-19 VACCINATION REQUIREMENT:

NIC has implemented a proof of vaccination requirement for their conference that all ASHA attendees must comply with. In order to access the ASHA meeting space, you must (1) be registered for the ASHA meeting and (2) upload your vaccination card to NIC's secure portal.

If you are registered for the NIC Conference and have submitted proof of vaccination:

- Register separately for the ASHA Executive Board Meeting at www.ashaliving.org/members-area/
- If you register and complete the proof of vaccination process prior to October 1, your badge will be mailed to you directly from NIC. If you register after October 1, pick up your badge from the **NIC** registration desk in the lobby, then stop by a Safe Expo desk for a daily security sticker. You may then proceed to the ASHA meeting room. ***Your NIC badge will be worn for both meetings.**

If you are NOT attending the NIC Conference:

- Register for the ASHA Executive Board Meeting at www.ashaliving.org/members-area/
- Next, upload proof of vaccination: https://mgf.ud.net/fmi/webd/NIC_2021
Enter your email address, first and last name. The NIC Reg Confirmation is: **ASHA**
ASHA-only attendees do not need to upload a photo ID to the site.
- Onsite, visit the **ASHA** registration desk in the lobby to pick up your NIC/ASHA badge, then stop by a Safe Expo desk for an approval sticker before proceeding to the ASHA meeting room. ***This custom badge will not provide access to the NIC Conference.**

Per NIC's COVID-19 safety requirements, all ASHA attendees must be fully pre-registered (registration plus submit proof of vaccination) to obtain entry. Onsite registration will not be available.




